Kaj krije zavarovanje ?

Kateri riziki so zavarovani?

Insurance of exhibits

Your participation at the Trade Fair should be successful and safe.
You can sign the insurance for your safety and the safety of your goods.

When is the insurance valid?

At the time of the exhibition organized by ICM Ltd.

What is insured?

The insurance covers all dangers an exhibitor faces regarding the exhibited equipment and goods as well as the damage that may be caused to other exhibitors, the organizer and visitors.

What risks are covered?

The insurance covers in the scope set by the General conditions for the insur-ance of fairs PG-sej-99-6 the damage of insured things caused by the following: Fire, explosion, storm, hail, water sink, landslide, snow slide, liquid sink, self ignition of store, mechanical break, fall of the plane, manifestations and demonstrations, clumsiness and negli-gence of workers and other persons, international act of the third party, burglary and robbery, theft as long as the things are at the fair are insured.

What else is insured?

The responsibility of the exhibitor for the damage caused to third person and the goods of the third party in the amount of 48.100 € after incident.

What other coverage is possible?

For the exhibitors that have machines operating at the Trade Fair for the presentation pur-poses, additional coverage for the mechanical break dangers can be arranged. This extended coverage requires an additional 10% payment. In this case, the insured person is required to participate in the amount of 10% of the incurred damage amounting to no less than 60 € and no more than 3.500 €.

What is the participation at damage?

The insured person is required to cover a certain amount of the damage caused by mechanical break, theft or responsibility :

- Mechanical break 40 €
- Theft 40 €
- Responsibility 20 €

When is necessary to call the police?

After an illegal entry, burglary or theft.

Up to what amount you are insured ?

Depends on the value of the equipment being exhibited.
When opting for insurance, it is important that the exhibitor is set into a proper class accord-ing to the value of the equipment being exhibited.

Where will the premium be paid?

The premium will be paid to the organizer of the fair following an invoice that includes all the costs / ordered items - exhibition space, equipment, registration fee, ecotax, insurance etc.

How to insure?

On the Application form for the participation in the trade fair, mark in front of the appropriate insurance amount, then sign and return the Application form to the organizer (ICM d.o.o.). The organizer will collect all signed documentation and forward it to the insurance company Triglav.

POGOJI RAZSTAVLJANJA

1.Spolna dolocila

Prijava je hkrati pogodba in pravno zavezujoča ter nepreklicna. Razstavljevec jo izpolni ter dostavi organizatorju. Prijav s pridržki organizator ne bo upošteval. Pogoji razstavljanja, določeni v Prijavi in pogodbi, narocninci, dodatekovi in tehnični ali/fali marketing materi ter drugim dokumentom iz strani organizatorja, veljajo za vse prireditve (sejme, razstave, events, konference in drugo), ki jih organizira organizator. Cene, ki veljajo za prireditev, so navedene na prvi strani te Prijave in pogodbe ter v dodatnih cenikih organizatorja. Podatek o razstavnem programu in razstavnih ekspozicijah je pogoj za sodelovanje razstavljevca na prireditvi. Razstavljevec sme razstavljati le prijavljene predmete. S podpisom te Prijave in pogodbe razstavljevec priznava in sprejema vse pogoje razstavljanja ter dovoljuje, da organizator obdeluje in uporablja podatke za svoje namene in jih posreduje tretjim osebam. Organizator si pridržuje pravico do odločanja o sprejemu razstavljevca in/ali razstavnih predmetov na prireditvi. Najmanjši razstavni prostor, ki ga razstavljevec lahko naroci, je 12 m2 neopremljenega notranjega prostora in 20 m2 neopremljenega zunanjea razstavnega prostora. Razstavljevec se obveže, da se bo držal rokov.

2.Dodelitev razstavnega prostora

Na prireditvi lahko razstavljajo razstavljevci, katerih razstavni predmeti ustrezajo vsebini prireditve. O pripustitvi razstavljevca na prireditvi in o dodelitvi razstavnega prostora odloča organizator, ki razporeja razstavni prostor v najboljšem interesu prireditve. Organizator si pridružuje pravico dodeliti do cca 10 % razstavnega prostora vec oz. manj. Vsako spremembo dodeljenega razstavnega prostora mora odobriti organizator. Organizator lahko prestavi razstavni prostor ali zapre vhode in izhode iz hal; in ce je potrebno, lahko opravi tudi druge spremembe glede razstavnega prostora. O teh ukrepih odloča organizator v interesu prireditve. Ce organizator iz kakršnega koli razloga ne more dati razstavljevca na razpolago že potrjenega razstavnega prostora, ima razstavljevec pravico do vračila že plačanega zneska.

3.Opdovp prijave-pogodbe

V primeru, da razstavljevec to pogodbo odpove, se obveže placati:

- 40 % cene razstavnega prostora, ce to prijavo-pogodbo odpove vec kot 90 dni pred pricetkom prireditve,
- 100 % cene razstavnega prostora, ce to prijavo-pogodbo odpove manj kot 90 dni pred pricetkom prireditve.

4.Placilo

Razstavljevec se obveže placati razstavni prostor, prijavnino za prireditev, prijavnino za vsakega sorazstavljavca, ekološko takso in vse ostale narocene storitve po cenah, ki so navedene v tej prijavi-pogodbi oziroma po veljavnih cenikih. Davke placa razstavljevec. Po dostavi izpolnjene in podpisane Prijave-pogodbe organizatorju, prejme razstavljevec predracun, ki ga mora v celoti in brez kakršnega koli odtegljaja poravnati v roku navedenem na predracunu. V roku opravljeno placilo predracuna je pogoj za nastop (sodelovanje) razstavljevca na prireditvi. Po opravljeni storitvi, izstavi prireditelj razstavljevca racun. Razstavljevec ga je dolžan poravnati v celoti in roku navedenem na racunu. V primeru zamude roka placila, organizator zaracuna razstavljevca še zakonite zamudne obresti. Razstavljevec lahko ugovarja racunu v 8 dneih po njegovem prejemu. Ugovor razstavljevca ne zadrži placila racuna in je dolžan poravnati racun v roku in na nacin, ki je določen s to prijavo-pogodbo.

5.Preklic dodelitve prostora

Organizator ima pravico zavrniti prijavo v primerih:

- ce je razstavljevec v casu prijave v poravnalnem, stečajnem ali likvidacijskem postopku,
- ce ima prireditelj do razstavljevca odprte terjatve iz prejšnjih prireditev,
- ce predmeti, ki naj bi bili razstavljeni na prireditvi, ne ustrezajo temi prireditve,
- ce razstavljevec ne dostavi dokumentov na zahtevo prireditelja.

6.Termin in kraj prireditve

Ce se mora prireditev casovno premakniti, skrajšati, podaljšati ali prostorsko premestiti, razstavljevci nimajo pravice odpovedati sodelovanja ali zahtevati povračila škode. Ce prireditve ni možno izvesti iz razlogov, za katere ne odgovarja organizator (višja sila, stavka in drugo), lahko organizator zahteva od razstavljevca placilo do 25 % cene razstavnega prostora. Te pravice pa organizator nima, ce je sam odgovoren za neizvedeno prireditev.

7.Tehnicni pojmi

Razstavljevci so dolžni upoštevati in se ravnati po navodilih organizatorja, hišnega reda, tehnicnih navodil in ustreznih Zakonov. Razstavljevci morajo predložiti organizatorju nacrtje (projekte) postavitve razstavnega prostora, izjave o težki gorljivosti opreme svojih razstavnih prostorov in druge dokumente, ki jih zahteva organizator. Te nacrtje (projekte) mora pred zacetkom montaže potrditi/odobriti organizator. Višina razstavnega paviljona lahko znaša največ 250 cm. Za izdelavo razstavnega prostora izven standardnih dimenzij mora razstavljevec pridobiti pisno dovoljenje organizatorja. Razstavljevec ne sme posegati pri postavitvi razstavnega prostora izven dodeljenega prostora lokacije.

8.Stalne karte za razstavljevce

Razstavljevec prejme za osebe na razstavnem prostoru določeno število brezplačnih stalnih kart. Pri nepravilnem ravnanju s kartami za razstavljevce si organizator pridržuje pravico do odvzema. Razstavljevca pripadata za vsako prijavo dve stalni karti ter za vsakih nadaljnjih 10 m2 notranjega razstavnega prostora po eno, oz. za vsakih nadaljnjih 20 m2 zunanjeega razstavnega prostora po eno, vendar skupaj največ 10 stalnih kart. Razstavljevec lahko dokupi stalne vstopnice po ceniku.

9.Montaža, demontaža

Delavci za montažo in demontažo morajo biti predhodno registrirani. Rokov za montažo in demontažo, ki so napisani v Informaciji in Navodilih za razstavljevce, se je treba natančno držati. Pri prekoračitvi termina za montažo/demontažo je organizator upravicen zaračunati penale in na stroške ter riziko razstavljevca pospravitvi razstavni prostor (paviljon). Po koncani demontaži mora razstavljevec prostor, na katerem je razstavljaj, vrniti v prvotno stanje in ga očistiti. V nasprotnem primeru je dolžan razstavljevec povrniti organizatorju vso nastalo škodo. Pri postavljanju in opremljanju razstavnih prostorov v času montaže prireditve in demontaže mora razstavljevec oz. njegov izvajalec upoštevati in ravnati v skladu:

- s predpisi s področja varnosti in zdravja pri delu,
- s požarno varnostnimi predpisi,
- s tehničnimi predpisi in standardi,
- s splošnimi pogoji dela na sejmišču,
- z navodili organizatorja.

Razstavljevec ne sme pred koncem prireditve odstraniti razstavnih predmetov (ekspонатov) iz razstavnega prostora. Razstavni prostor sme razstavljevec predcasno zapustiti samo na podlagi pisnega dovoljenja prireditelja.

10.Jamstvo in zavarovanje

Organizator ne odgovarja za poškodbe, izgube, unicenje ali odtujitve stvari razstavljevca oz. njegovega izvajalca (razstavni predmeti, oprema in drugo), njunega osebja in tretjih oseb kakor tudi ne za poškodbe razstavljevca oz. njegovega izvajalca, njunega osebja in tretjih oseb, nastale zaradi požara, viharja, toce, strele, loma, izliva vode, tatvine ali katerega koli drugega vzroka.

Organizator ne odgovarja za poškodbe, izgube, unicenje ali odtujitve stvari in poškodbe tretjih oseb, nastalih zaradi ravnanja razstavljevca oz. njegovega izvajalca na razstavnem prostoru oz. sejmišču. Razstavljevec oz. njegov izvajalec sklene ustrezna zavarovanja na svoje stroške. Razstavljevec oz. njegov izvajalec odgovarja za nastalo škodo in nesreco, ki jo povzroci organizatorju in/ali tretji osebi na razstavnem prostoru oz. sejmišču on sam ali njegovo osebe.

Organizator ne prevzema nikakršnega jamstva za vozila, ki jih na območju sejmišča in parkirišča pustijo razstavljevci, njihovi uslužbenci ali pooblašcenci oz. njihovi izvajalci. Za pomanjkljive tekste, tiskarske napake, oblikovne napake, napacen prevod itd organizator ne prevzema nobene odgovornosti.

Razstavljevec ne sme oddati dodeljenega razstavnega prostora in/ali propagandnega prostora oz. njegovega dela tretji osebi. V primeru kršitve si organizator pridržuje pravico dodatno zaračunati razstavljevca 100 % cene dodeljenega razstavnega oz. propagandnega prostora.

Razstavljevec se obvezuje, da bo vedno prisoten na svojem razstavnem prostoru v delovnem casu montaže, demontaže in trajanju sejma. V tem casu prevzema razstavljevec vso odgovornost za opremo, in razstavne eksponate. V primeru kakršne koli škode, ki jo je razstavljevec povzročil organizatorju ali na opremi oziroma objektu je dolžan takoj in brez ugovora poravnati.

11.Predstavitve

Razstavljevec mora najkasneje 45 dni pred prireditvijo pisno obvestiti organizatorja, ce bo imel na dodeljenem razstavnem prostoru kakršne koli prireditve (npr.: glasbeni nastop, srečanje, ..., itd.) Organizator je upravicen po že izdanim pisnem dovoljenju omejiti ali prepovedati prireditev, ki ne ustrezajo prijavi, predpisanim pravilom in standardom, povzročajo hrup, umazanijo, prah, uhajanje plinov oz. kakor koli drugega ovirajo normalen potek prireditve oziroma so nevarne. Predstavitve lahko potekajo izključno na dodeljenem razstavnem prostoru razstavljevca oziroma za to namenjenem prostoru.

12.Dejavnost razstavljevca – dokumenti

Organizator ima pravico ob prijavi zahtevati od razstavljevca:

- Obtrno dovoljenje oziroma registracijo z odločbo pristojnega organa, da so izpolnjeni z zakonom določeni pogoji za opravljanje dejavnosti
- Ustrezno soglasje pristojnega zdravstvenega in veterinarskega inšpektorata, ce bo razstavljevec na prireditvi opravljal promet z živili in s predmeti splošne rabe, degustacije živil ali demonstracijo predmetov splošne rabe oz. gostinsko dejavnost.
- Ustrezne druge dokumente za izvajanje dejavnosti na prireditvi

Organizator ima pravico odpovedati sodelovanje (nastop) razstavljevca na prireditvi, ce ne dostavi oziroma si sam ne priskrbi ustrezne potrebne dokumente.

13.Fotografiranje, snemanje in risanje

Organizator ima pravico razstavne paviljone in razstavljene predmete fotografirati, narisati in/ali posneti na filmski, video trak ali kakršn koli drug medij ter gradivo uporabiti za lastne potrebe in/ali za splošno uporabo promocije prireditve. Razstavljevec se odpove vsem ugovorom iz naslova avtorskih pravic. Brez odobritve organizatorja razstavnih paviljovov ni dovoljeno fotografirati ali narediti njihove risbe oz. jih posneti s strani tretjih oseb, izjema je le lastni razstavni paviljon.

14.Ciščenje razstavnega prostora

Organizator skrbi za čiščenje sejmišča in hodnikov (hojnic) v halah. Čiščenje razstavnih prostorov je dolžnost vsakega razstavljevca; po narocilu pa ga na stroške razstavljevca lahko prevzema organizator oz. od njega določene organizacije.

15.Sodišce

Organizator in razstavljevec bosta vse spore reševala sporazumno. Ce do sporazuma ne bi prišlo, je za rešitev spora pristojno sodišce v Celju.

TERMS AND CONDITIONS

1. General terms of participation

This application form is a contract. It is legally binding for the exhibitor and is valid as an irrevocable agreement. The exhibitor fills it in and delivers it to the organizer. Application forms with stipulations will not be considered by the organizer. The terms and conditions set out in the Application form, the order forms, the technical and marketing services kits, and other documents issued by the organizer are valid for all events in the organization of ICM Ltd (fairs, exhibitions, conferences, congresses, other events). The prices valid for the event are stated on the first page of this Application form and in the additional price lists related to the event. Providing information on the exhibition program and exhibits is a condition for the exhibitor’s participation in the event. The exhibitor may exhibit only products and services previously listed in the entry form.

By signing this Application form/ Contract, the exhibitor acknowledges and accepts all the conditions of the exhibition and allows the organizer to process and use the data for their purposes and pass it on to third parties.

The organizer reserves the right to decide on the admission of the exhibitor and/or exhibits to the event. The minimum exhibition space that can be ordered is 12 m2 of unequipped indoor space and 20 m2 of unequipped outdoor exhibition space. The exhibitor undertakes to respect the deadlines of this Application form/Contract.

2. Allocation of exhibition space

Exhibitors whose exhibits correspond to the event’s content can exhibit at the event. The admission of the exhibitor to the event and the allocation of the exhibition space is decided by the organizer, who arranges the exhibition space in the best interest of the event’s success. The organizer reserves the right to grant up to 10% more or less of the exhibition space. The organizer should approve any modification of the allocated exhibition space. The organizer may relocate the assigned exhibition space or close the entrances and exits of the halls; and, if necessary, may make other changes to the exhibition space. These measures are decided by the organizer in the interest of the event. Should the organizer for whatever reason, not be able to give aid to disposal to the exhibitor the already confirmed exhibition stand, the exhibitor is entitled to the reimbursement of the sum he had paid.

3. Termination of the application form/contract

In case the exhibitor terminates this contract, he undertakes to pay:

- 40% of the price of the exhibition space if this contract is canceled more than 90 days before the start of the event,
- 100% of the price of the exhibition space if this contract is canceled less than 90 days before the start of the event.

4. Payment

Exhibitors undertake to pay the exhibition space, the registration fee for the event, the registration fee for each co-exhibitor, the ecological tax, and all other ordered services at the prices stated in this application form/contract or according to valid price lists. Taxes (VAT) are paid by the exhibitor.

Once the completed and signed application form/contract is submitted to the organizer, the exhibitor will receive a pre-invoice, which he should pay in full and without any deduction within the period specified in the pre-invoice.

The payment of the pre-invoice within the deadline is a condition for the participation of the exhibitor at the event. After the service has been performed ie on the last day of the exhibition, the organizer issues a final invoice to the exhibitor. The exhibitor is obliged to pay it in full by the deadline stated on the invoice. In case the payment term is exceeded, the organizer charges the exhibitor a legal interest for delayed payment. The exhibitor can object to the invoice within 8 days of its receipt. The objection of the exhibitor does not suspend the payment of the invoice and he is obliged to settle the invoice within the deadline and in the manner specified in this application form/contract.

5. Cancellation of the space allocation

The organizer has the right to reject the application in the following cases:

- if the exhibitor is in settlement, bankruptcy, or liquidation proceedings at the time of application,
- if the organizer has outstanding claims against the exhibitor from previous events,
- if the products to be exhibited at the event do not correspond to the theme of the event,
- if the exhibitor does not deliver documents at the request of the organizer.

6. Date and place of the event

If the exhibition has to start earlier or be postponed, if its duration has to be shortened or extended, or if it has to be spatially relocated, the exhibitor does not have the right either to cancel the exhibition or to claim indemnity. If the exhibition can not be performed for reasons beyond the control of the organizer (force majeure, strike, riot, etc.), the organizer may require of the exhibitor a payment in the height of up to 25 % of the price of the exhibition stand. However, the organizer is not entitled to such a right, if he is responsible for the failure of the exhibition.

7. Technical conditions

Exhibitors are obliged to follow the instructions of the organizer, meet the requirements of the technical standards, respect the house rules and the relevant laws. Exhibitors must submit to the organizer a plan of the set-up and the equipment of the exhibition space, along with all other documents required by the organizer. When assembling the exhibition stand, the exhibitor may not usurp the area beyond his allocated exhibition space; he should entirely stick to the instructions for exhibitors.

These plans must be confirmed/approved by the organizer before the start of assembling. The height of the exhibition booth can not exceed 250 cm. To build a stand that deviates from the standards, the exhibitor must obtain the written permission of the organizer.

8. Exhibitor passes

Exhibitors are entitled to two free exhibitor passes for booths of size 12 m2 and to one more for each additional 10 m2 of indoor exhibition space or each additional 20 m2 of outdoor exhibition space. The maximum number of free exhibitor passes is 10. In case of improper handling of the exhibitor passes, the organizer reserves the right to withdraw them. Exhibitors can buy additional exhibitor passes

9. Assembly, disassembly

The workers in charge of assembling and dismantling must be pre-registered. The schedule of assembling and dismantling stated in the information for exhibitors should be strictly observed.

If the dismantling term is exceeded, the organizer is entitled to charge the exhibitor penalties and disassemble the exhibition space and clean it at the expense and risk of the exhibitor. After the dismantling is completed, the exhibitor must return the space where he exhibited to its original condition and clean it. If it is not possible to return the exhibition space to its original condition, the exhibitor is obliged to reimburse the organizer for all damage.

During the assembling and disassembling, the exhibitors or their contractor shall comply with and act in accordance with:

- regulations on safety and health at work,
- fire safety regulations,
- technical regulations and standards,
- general conditions of work at the fairgrounds,
- instructions of the organizer.

Exhibitors are not allowed to remove their exhibits from the exhibition space before the end of the event. Exhibitors may leave the exhibition space earlier only with the written permission of the organizer.

10. Warranty and insurance

The organizer will not be held responsible for any damage, loss, destruction, or alienation of the property (exhibits, equipment, etc.) of the exhibitors, their contractors, their staff, and third parties, as well as not for injuries to the exhibitors, their contractors, their personnel and third parties caused by fire, storm, hail, lightning, breakage, water spill, theft or any other cause. The organizer is not responsible for any damage, loss, destruction, or alienation of things and injuries to third parties caused by the actions of the exhibitors or their contractors at the exhibition space or the fairgrounds.

Exhibitors respectively, their contractors shall take out appropriate insurance at their own expense.

The exhibitor, respectively, the company setting up the exhibition stand will be held responsible for the damage or injury caused to the organizer and/or to a third party at the exhibition stand resp. exhibition grounds, either by himself or by his staff.

The organizer will not be held responsible for any damages caused to vehicles left in the fairgrounds area by exhibitors, their employees, or their contractors.

The organizer will not be held responsible for the materials provided by the exhibitors, (content, typographical errors, design errors, incorrect translation, etc.)

The exhibitor is not allowed to cede the granted exhibition stand or advertising space resp. parts of them to any third person. In case of violation, the organizer reserves the right to charge the exhibitor an additional 100 % of the price of the granted exhibition stand resp. advertising space.

The exhibitor undertakes to be always present at his exhibition space during the working hours of assembly, disassembly, and the duration of the fair. During this time, the exhibitor assumes all responsibility for the equipment and exhibits. In case of any damage caused by the exhibitor to the organizer or the equipment or facility, he is obliged to pay immediately and without objection.

11. Events at the allocated booth

In case an exhibitor intends to host an event (musical show, meeting, reception, etc) at the allocated booth, he must notify the organizer in writing no longer than 45 days before the start of the exhibition about his plans. The organizer is entitled to restrict or prohibit an event that does not comply with the prescribed rules and standards, interferes with the normal course of the exhibition, or is dangerous. These events can take place exclusively in the allotted exhibition space of the exhibitor or in the space intended for that purpose.

12. Exhibitor’s activities – documents

The organizer has the right to request from the exhibitor at registration:

- Business permit or business registration certificate issued by a relevant authority which proves that the exhibitor fulfills the conditions for performing the activity specified by law.
- Relevant sanitary and veterinary certificate issued by an authorized inspectorate, if the exhibitor plans to trade in Foodstuffs and general consumer goods,organize food tastings or demonstrations of general consumer goods, or perform catering services. The organizer has the right to reject the application by the exhibitor if the latter fails to supply the required documents.
- Other documents relevant to carrying out activities at the event

The organizer is entitled to cancel the participation of the exhibitor at the event if he does not provide the necessary documents.

13. Photography, recording, and drawing

The organizer is entitled to photograph, draw and/or record the exhibition stands and exhibits, draw them, or shoot them on film resp on a videotape or any other medium and to use the material for his needs. The exhibitor renounces all contestations arising from copyright. Photographing, filming, or drawing of the exhibition halls, exhibition stands, and exhibits by third parties are not allowed. The only exception is filming, photographing, and drawing of the own exhibition stand.

14. Cleaning the exhibition space

The organizer provides for the cleaning of the fairgrounds and walkways in the halls. Every exhibitor is responsible for the cleaning of their exhibition space. Cleaning can be taken over by the organizer or by a cleaning services provider designated by the exhibitor.

15. Jurisdiction

The organizer and the exhibitor undertake to settle all eventual disputes amicably. If no agreement is reached, the court in Celje is competent to resolve the dispute.
